PRODUCTS AND PERSONS COVERED:

Chilewich offers this warranty for its wall textile products. The warranty is for the original end-user only and is non-transferable and non-assignable.

WARRANTY COVERAGE:

Unless otherwise stated, the covered Chilewich products meet or exceed Association for Contract Textiles quality and performance standards when used under normal conditions and will be free from defects in material and workmanship for a period of fifteen years commencing upon the original ship date from the manufacturer.

WARRANTY EXCLUSIONS:

Installation and maintenance instructions listed at www.chilewich.com/contract/technical must be followed for any warranty to remain in effect. Additional after-market finishes applied after purchase will void any Chilewich warranty. This warranty does not cover damage or product failure caused by: (a) mold or mildew; (b) reverse crocking; (c) abusive or improper treatment; (d) improper storage or handling; (e) use of incompatible or unspecified adhesive(s), materials, tools or equipment; (f) inadequacies or defects in building design or construction; and (g) any other causes unrelated to any Chilewich product defect.

REMEDIES:

Warranty-related claims must be submitted in writing to Chilewich within the above stated warranty period.

If the product is defective, Chilewich will, at its sole option, refund the purchase price or replace the product with a mutually agreed upon product. These remedies do not include any labor costs. These are the end-user's sole and exclusive remedies.
